vertically slowly away from Metal Housing.

- Step 6: Remove the rubber washer (1x) and the screw on board(1x).
- Step 7: Detach all Flexible Printed Circuits (3x) and connector (2x) to remove the charger PCBA.
- Step 8: Remove the 2 screws of the frame and take it out from the Metal Housing.
- Step 9: Remove battery by tilting it up and dispose of according to local regulations.

IQOS ILUMA i™ Pocket Charger (Model M0022):

- Step 1: The device should be fully discharged before disassembling it.
- Step 2: Open the door.
- Step 3: Remove Door Cover with fingers.
- Step 4: Unfasten the 2 screws on top and bottom.

- Step 6: Unfasten the electronic circuit board (1 screw only) and remove the retainer.
- Step 7: Unplug battery connector on the circuit board. Do not cut battery wires.
- Step 8: Unplug light channel FPC connector on the circuit board, and detach the 2 kapton tapes on battery.
- Step 9: Remove battery by tilting it up and dispose of according to local regulations.

- Step 3: Open the retainer cap.

- Step 6: De-solder the battery tab from PCBA side and lift it up.
- Step 7: Remove battery and dispose of according to local regulations.
